How to seek permission for orienteering events

It is usually the responsibility of the Event Organisers to ensure we have the appropriate permission for our events. See the tables below for land owner/manager information for each map.

You can find the following documents on the OT Organisers' Toolkit:

- Insurance Certificate of Currency
- A generic risk assessment form please review and adapt as necessary
- A template letter to landowner seeking access

Site Plan

If a site plan is required, usually a pdf copy of our map showing the location of the assembly area is sufficient.

- In Condes, insert a start triangle at the assembly area, and a text box saying something like 'Event hub is at the triangle. Approximately 20 control flags will distributed over the area represented by this map'.
- Export the 'all controls' map to pdf.

If it is necessary to show where the map is, provide a link to Omaps.

Private landholders

The OT Mapping Officer will provide you with this information when they send you the map. If there are any changes please feed this back to the Mapping Officer so the information can be updated.
